- 1. The Board meeting was called to order at 6:39 pm by Dr. Akin
- 2. Mr. Akbaba moved to approve the agenda items. Mrs. Duprey 2nd the motion. The board unanimously approved the agenda.
- 3. Mrs. Duprey moved to approve the December 20th 2023, board meeting minutes. Mr. Akbaba 2nd the motion. The board unanimously approved the December 2023 meeting minutes.
- 4. Principal Report
 - a. Principal Tekin provided information regarding the ZooTampa enrolment event with the invitation from Hillsborough County Schools Board Member Dr. Stacy Hahn.
 - b. Hillsborough County School Board Member Karen Perez visited New Springs Schools.
 - c. Principal Tekin discussed hiring updates for the upcoming school year.

The plan includes a 5% approximate increase on salaries as well as 403b retirement match from workplace to increase to 5.5%. The total impact to school budget is around 215k. Mr. Akbaba moved to approve the salary and benefits plans for 24-25 school year. Mrs. Duprey 2nd the motion. The board unanimously approved the salary & benefits increase for 24-25 school year.
