- 1. The Board meeting was called to order at 6:47 pm by Dr. Akin
- 2. Dr. Akin moved to approve the agenda items. Mrs. Duprey 2nd the motion. The board unanimously approved the agenda.
- 3. Mrs. Duprey moved to approve April 16th 2025, board meeting minutes. Dr. Akin 2nd the motion. The board unanimously approved the April 2025 meeting minutes.
- 4. Principal Report
 - a. Principal Tekin provided information regarding the NSS school grade for 2024-25. Students performed better than last year and overall score increased 1%.
 - b. Enrollment shows 360 for the upcoming year. NSS will continue efforts for stable student numbers.
 - c. Hiring Needs are completed. NSS has 1 full time substitute due to 1 of the teachers decided to move after signing contract.
 - d. Charterslink Compliance score was displayed at 92%.
